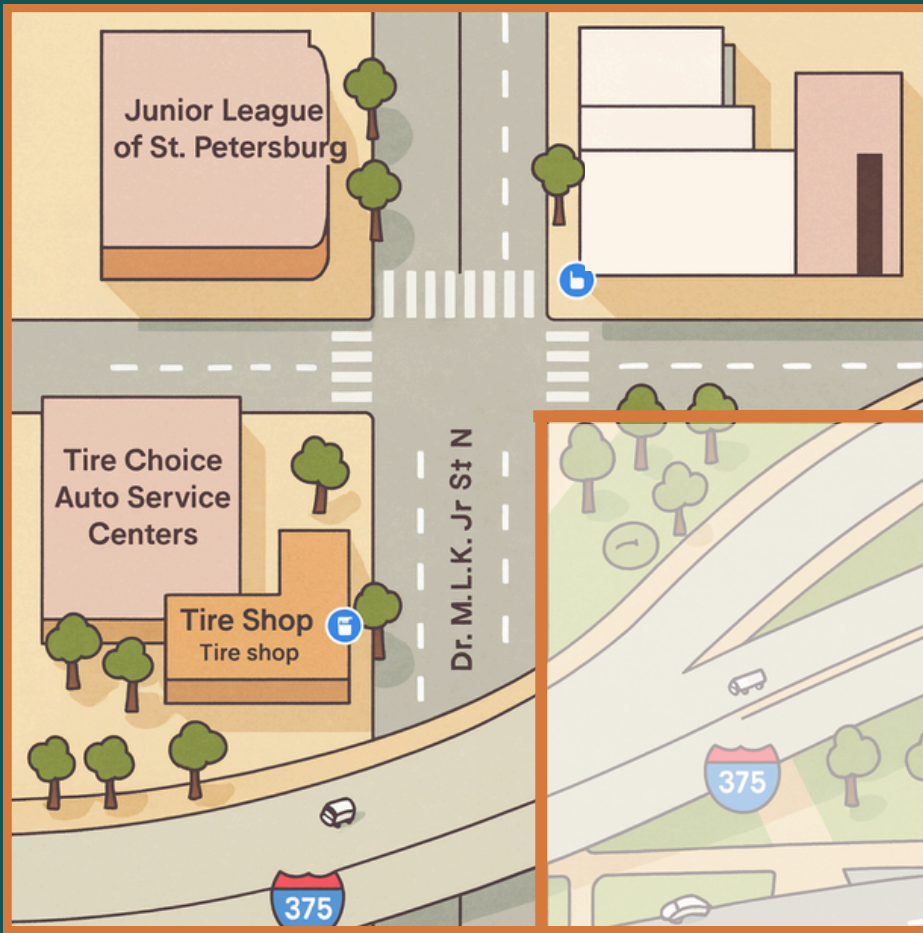

We're excited to have you join us for our Fall Festival! This agreement explains what you can expect from us, and what we need from you to keep everyone safe, happy, and protected.

1. Understanding the Risks

We want you to know that participating in an outdoor festival has some risks — like bad weather, loss or damage to your property, or accidental injury. By signing this agreement, you understand and accept these risks.

2. Release of Liability

You agree that MLK Business District, along with our team, volunteers, sponsors, and partners, won't be responsible for any injuries, losses, or damages that may happen during the event — whether caused by weather, accidents, other people, or things we can't control.

3. Your Responsibility to Protect Us

If any claim, cost, or legal issue comes up because of your business, products, services, or actions at the festival, you agree to take responsibility and cover any expenses (including legal fees) so the event organizers are not held liable.

4. Following the Rules

You'll follow all event rules and any local, state, or federal laws that apply. If your business needs a permit, license, or insurance, it's your responsibility to get it before the event.

5. Your Property & Insurance

We'll do our best to provide a safe environment, but we can't be responsible for lost, stolen, or damaged property. We recommend you carry your own liability insurance to protect your business.

6. Weather & Event Changes

The Fall Festival will happen rain or shine unless we decide it's unsafe. If we need to cancel because of weather or other situations we can't control, refunds will not be issued.
